

Applications received after the due date and time will not be considered. The Commission is not responsible for any postal delay. The envelope containing the application may be superscribed as "Application for the post of Director (Engineering)".

3. If the candidates are employed in Government/Public Sector Undertakings(PSU), their applications must be routed through their employer concerned along with Part –

B of the application proforma. However, an advance copy of the application may also be forwarded by the candidates.

4. If the application received is incomplete or if the required copies of certificates/ demand draft are not enclosed, the application will not be considered. No further correspondence will be entertained in this regard.
5. Applicants are requested to submit the application only if they satisfy the qualifications, experience etc., as indicated. Candidates are requested to make a comparison of the qualifications and experience required as well as possessed by them so as to enable their candidature.
6. The following needs to be enclosed to the application:
 - a) A demand draft for Rs.500/- drawn in favour of Secretary, Andhra Pradesh Electricity Regulatory Commission, payable at Hyderabad. Payment of Fees is exempted for the reserved categories of candidates as per the Government rules. Applications received without fees will be summarily rejected. Fees paid shall not be refunded under any circumstances.
 - b) In case of applicants belonging to SC/ST/BC, fresh community certificate issued not earlier than six months from the date of notification by the concerned revenue official shall be produced.
 - c) Two recent passport size photographs placed in a small pouch in addition to the one which is pasted on the application form (total 3 photographs).
 - d) Self attested copy of SSC certificate as a proof of Date of Birth.
 - e) Self attested copies of University/Board certificates as a proof of acquiring qualifications.
 - f) Self attested copies of experience certificates may be enclosed. If an experience certificate is given by the Personnel/HR department, a copy of the same may be enclosed. Else, appointment order and relieving order are to be enclosed.
