PUBLIC NOTICE

Notice is hereby given to all that Southern Power Distribution Company of A.P Ltd (SPDCL) and Eastern Power Distribution Company of A.P. Ltd (EPDCL) filed a petition u/s 94 (1) (f) of the Electricity Act, 2003 r/w Clause 56 & 59 of APERC (Conduct of Business Regulations), 1999 seeking review / modification / rectification of errors in the order dt. 09-05-2014, wherein Commission determined Wheeling Tariff for Distribution Business for FY 2014-15 to 2018-19. The said petition and the application for interim relief are taken on the file of the Commission as R.P. No. 12 of 2015 and I.A.No. 20 of 2015, respectively.

2. In the review petition, the DISCOMs essentially request the Commission to consider exemption of wheeling charges to Wind, Solar and Mini hydel generation and to include Wind, Solar and Mini hydel generation in contracted capacities of DISCOMs.

Copy of the petition and the application filed by the DISCOMs in R.P.No. 12 of 2015 and I.A. 20 of 2015 can be obtained from the offices of the Chief General Manager (Operation), at the head offices of the DISCOMs at Tirupati & Visakhapatnam and in the offices of Superintending Engineers, Operation (Circle offices) at Nellore, Vijayawada, Guntur, Ongole, Srikakum, Vizianagaram, Rajahmundry and Eluru. Interested persons may inspect / peruse the said petition & application and take note thereof, during the office hours at any of the above mentioned offices free of cost.
