- iii) Licensees are directed to publish a public notice in Telugu (in Telugu text) & English (in English text) newspapers having circulation throughout the State of Andhra Pradesh inviting views / objections / suggestions of the stakeholders on or before 10-05-2016 in the prescribed format.
- iv) Licensees should upload their filings of CSS in their respective official websites in pdf format in full shape as filed before APERC for facilitating interested person(s) to view/download.
- v) Hard copies of filings are to be made available from 11-04-2016 at corporate office and circle offices at district level. The addresses of the offices where the copies of CSS filings can be obtained and addresses for furnishing the objections/suggestions shall be clearly indicated in the Public Notice.
- vi) Licensees should permit the interested person(s) for perusal of CSS filings and to take notes thereof during office hours at any of the said offices at free of charge. Person(s)/Objector(s) can also procure copy of CSS filing on payment of Rs.10/- for each copy.
