**PUBLIC NOTICE INVITING OBJECTIONS**

TAKE NOTICE that M/s. Global Energy Pvt. Ltd., 207, Gera Imperium II, Patto Plaza, Panjim, North Goa, Goa – 403 001 submitted an application for grant of intra-state electricity trading license within the geographical area of Andhra Pradesh, as per the terms and conditions specified in APERC (Intra State Electricity Trading) Regulation, 2005, {Regulation 6 of 2005}.

The applicant published notice of its application along with particulars as mentioned in Appendix-I of said Regulation No.6 of 2005 in Business Standard and Times of India on 20-06-2014, apart from publication in two vernacular newspapers on 22-06-2014. The Commission did not receive any objection to grant of requested license to the applicant in response to such publication within the prescribed time. However, on 19-12-2014, a letter dated 18-12-2014 is received from authorised signatory, Ushdev Engiteh Limited (earlier known as Suzlon Engiteh Limited) requesting the Commission to look into the conduct of the applicant before granting intra state license in order to safeguard the interests of other power generators in the State of Andhra Pradesh.

On 20-12-2014, the Commission provisionally decided to grant Intra State Trading license to the applicant subject to the general terms and conditions specified in Regulation No.6 of 2005 and Appendix III thereof and any other specific terms and conditions that may be found necessary on a thorough examination of the entire matter. The applicant will also be required to pay required fee as specified in the Regulation No.6 of 2005.


The application can be inspected at the office of the Commission at the address mentioned above and at the main office of the applicant. The applicant is directed to upload application on its website to enable it to be downloaded. Copies of the application along with Annexures 1 to 16 can also be obtained from the applicant either in person or by post, on payment of Rs.100/-.

Any person interested in objecting to or otherwise making representation in regard to grant of intra state electricity trading license may submit objections/representation to the Secretary, Andhra Pradesh Electricity Regulatory Commission within fifteen (15) days by hand delivery or by registered post and should serve a copy of the objection/representation to the applicant at the address mentioned above. The person filing the objection/representation should give the following particulars:-

- a. Name and full address
- b. Grounds/reasons in support of the objection/representation together with documents or evidence, if available.
- c. Whether wishes to be heard in person or through authorized representative at the time of hearing.

ALSO TAKE NOTICE that the above mentioned application for grant of intra state electricity trading license will be taken up for hearing before the Commission on 21-02-2014 at 11:00 AM.
