In terms of section 87 (1) of the Electricity Act, 2003 read with Regulation No. 2 of 2004, the State Commission may, by notification establish with effect from such date as it may specify in such notification, a Committee to be known as the State Advisory Committee.

2. Accordingly, the following notification will be published in the Ex-ordinary issue of Andhra Pradesh Gazette.

## NOTIFICATION

In exercise of the powers conferred by section 87 of the Electricity Act, 2003 [Central Act No. 36 of 2003] and the Andhra Pradesh Electricity Regulatory Commission (Constitution of State Advisory Committee and its functioning) Regulation, 2004 (Regulation No. 2 of 2004), the Andhra Pradesh Electricity Regulatory Commission hereby constitutes the State Advisory Committee (SAC) with 21 members as specified in Annexure with Sri Justice G. Bhavani Prasad, Chairman/APERC as the *ex officio* Chairman of SAC and Sri P. Raghu, Member/APERC and Sri P. Rama Mohan, Member/APERC as *ex officio* Members of SAC, with effect from 01.05.2018.

- 2. The functions of SAC shall be as detailed in section 88 of the Electricity Act, 2003 read with the Regulation No. 2 of 2004.
- 3. The tenure of the members of the said Committee shall be for a period of 3 (three) years with effect from 01-05-2018.
