The Andhra Pradesh Electricity Regulatory Commission has constituted the State Advisory Committee (SAC) on 31-12-2014 with a tenure of three (3) years with effect from 01-01-2015 with ten (10) members as detailed below with Sri. Justice G. Bhavani Prasad, Chairman, APERC as the Ex-Officio Chairman of SAC.

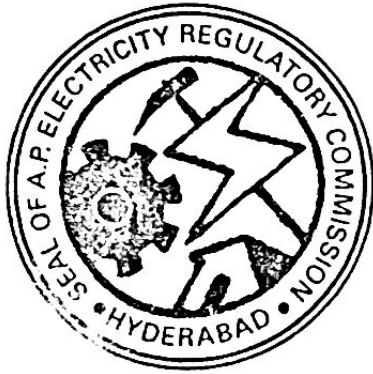
The Secretary of the Commission Dr. A. Sreenivas will be the Ex-Officio Secretary to the SAC.


The State Advisory Committee shall consist of not more than twenty-one (21) members to represent the interest of commerce, industry, transport, agriculture, labour, consumers, non-governmental organisation and academic and research bodies in the electricity sector. The Commission has sought for nominations from the public by a notice dated 31-12-2014 hosted in its official website (www.aperc.gov.in) in respect of categories which are presently un-represented / under-represented. The nominations have to be received in the Commission within 10 days of the notification.

The objects of the State Advisory Committee under section 88 of the Electricity Act, 2003 shall be to advise the Commission on –

- (i) major questions of policy;
- (ii) matters relating to quality, continuity and extent of service provided by the licensees;
- (iii) compliance by licensees with the conditions and requirements of their licence;
- (iv) protection of consumer interest; and
- (v) electricity supply and over all standards of performance by utilities.
