Notification for engagement of Consultants in the area of Regulatory Affairs

APERC intends to engage Consultants who are expertise in the area of Regulatory Affairs on contract basis.

The Scope of work of the Consultants is as follows:

- a) Determining Retail Supply, Transmission, Distribution & Wheeling Tariffs including True-ups/FPPCA.
- b) Determining Generation tariff and Capital Costs (fixed and/or variable costs) of Conventional & RE Generators.
- c) Power Procurement & Planning, approving the Power Purchase Agreements (PPAs) covered under section 62 & 63 of Electricity Act, 2003 in respect of Conventional Power plants and Renewable Energy plants.
- d) Approving Capital investments in the Transmission and Distribution sectors.
- e) Load Forecasts & Resource plans (Power procurement planning, Transmission planning, Distribution planning).
- f) Cost of Service computations and working out full cost recovery tariffs, determining Cross Subsidy Surcharge.
- g) Analysing the SLDC data on power purchases and the short term power purchases by the DISCOMs.
- h) Formulation of Concept Notes / Discussion papers and Regulations concerning Transmission, Distribution & Wheeling, Renewables, BESS, Metering, Open Access and related activities thereto.

Qualification required:

- a) Graduate in Engineering preferably in Electrical.
- b) MBA (Power Management) from reputed institutions like NPTI / UPES, Dehradun or PGDM (Energy Management) from NTPC School of Business.

Note: Courses should be on regular basis. Part time / correspondence courses will not be considered.

Experience & Competencies required: Qualification for the post is minimum three years of work experience in regulatory affairs connected with Power Sector in Transmission / Distribution / Generation / Renewable.

Skills required:

- a) Good understanding of the Regulations relating to the power sector, especially of the Electricity Act, 2003 and Policies under the Act, Electricity Rules, 2005 and its amendments, Electricity (Rights of Consumers) Rules, 2020 and its amendments.
- b) Expertise in MS-Excel, MS-Word, Power Point / other presentation Apps is mandatory.
- c) Proficient in reporting and in preparing presentations.
- d) Good written and verbal communication skills.

Consolidated Remuneration: Rs.1,50,000 to Rs.1,75,000 per month based on the experience for the first one year and suitable escalation on the remuneration from the 2nd year based on the satisfactory performance. Deduction of TDS on monthly remuneration applicable as per relevant rules.

General Terms and conditions:

- 1) The selection process will be based on the performance in the interview. The candidates called for interview would be required to bring original documents relating to qualification, experience and salary slips for the past six months. These documents shall be examined before the interview.
- 2) The engagement shall be on a purely contract basis for a period of three years. However, the period of engagement may be extended based on the satisfactory performance of the candidate. Such engagement shall not vest any right whatsoever to claim for regular appointment or continued contractual engagement in the Commission.
- 3) The Consultant is eligible for fifteen (15) days of Casual Leave and five (5) days of Optional Holidays per Calendar Year (proportionately for a lesser period) from the date of joining. The Consultant shall not be entitled to any remuneration for the period of absence beyond the entitled leave as above.
- 4) The Consultant is not eligible for any medical facilities provided by the Commission.
- 5) The contract can be terminated by either party by giving three months notice in writing.
- 6) APERC reserves the right not to fill up the positions, without assigning any reasons whatsoever.
